Dear members,

Recent events in NSW have highlighted the necessity of communities working together. Bushfires in NSW between 19th October and early November destroyed 208 homes and damaged an additional 122 homes. Firefighters battled more than 71 fires, 29 of which were uncontained, schools were closed, hospitals and nursing homes were evacuated. A state of emergency was declared and whether by good management or luck loss of life was minimal. The importance of Bushfire safety plans was highlighted and a Rural Fire Service Officer was heard to say "if you don't have a plan, here's one. Pack your car and get out" (www.news.com.au). Communities were asked to evacuate or alternately to help out; and they did.

To those members of ANNA or their families who have lost homes please accept our commiserations. Please don't hesitate to contact us if we can be of help, as an example reissuing receipts or confirmation of attendance at conferences. To members or their families who form part of the large cohort of volunteers fighting the fires or providing food, housing or clothing in the recovery ANNA expresses our thanks.

What made this more poignant was that colleagues lost their homes and at the WFNN meeting 2013 in Gifu the ethics of disaster and the way communities respond was discussed in a special lecture from Tetsuro Shimizu entitled Origin and Essence of caring in Healthcare: A philosophical and Ethical investigation. Using the earthquake, tsunami and subsequent nuclear disaster in northern Japan, Miyagi Prefecture, on March 14, 2011 Tetsuro Shimizu outlined how in times of need people saw themselves as very similar and worked together to survive. I'm not sure it was prophetic when the similarities of behaviour between the Japanese people during the Tsunami and Australian people during bushfires was highlighted by Emma Everingham but it was certainly true.

There are reports on the WFNN meeting elsewhere in this newsletter but I must say it was an amazing sight when the call (Aussie, Aussie) went out at the Welcome Dinner and so many answered. Over 40 Australian delegates with the majority presenting papers or posters. Well done! Let's see if we can improve at future international meetings. Remember that presenting at ANNA conferences provides a fantastic opportunity to develop your presentation skills.

The 40th anniversary ANNA meeting entitled 'Yesterday, today and tomorrow....40 years on. The evolution of Neuroscience Nursing will be held in Canberra at Hotel Realm from Wednesday 7th to Friday 9th May. Call for abstracts has been sent out and we look forward to your submissions. As trade is an important component of the conference remember to mention sponsorship to any company representatives you meet. The sponsorship proposal is available on the website www.anna.asn.au

The website is also updated with educational opportunities that the ANNA Executive is advised about. Together with the President, prepare agendas for Executive Committee meetings;


Maintain minutes of Executive Committee meetings;

Barbara Lester Scholarship: Post conference report

I was fortunate to have been awarded the Barbara Lester Scholarship to assist me in attending the World Federation on Neuroscience Nurses Congress in Gifu, Japan in September, 2013. I had a poster accepted into the conference and so attending the conference and representing my poster (and my colleague Stephanie Gilmore who worked with me on it!), my hospital and my country was very important to me. I had a number of objectives that I wished to achieve during my time at the conference:

1. To gain new knowledge and insights into international neuroscience nursing.

There were so many inspiring presentations from all around the world. I have most definitely learnt some different perspectives that I am looking forward to sharing with my colleagues. Talks that I particularly enjoyed were Lena Aadal's presentation on 'Nursing roles and functions in the inpatient neuro rehabilitation of stroke patients- a literature review', also Dawn Tymianski's presentation on 'Clinical pathways for the assessment of the deterioration patient' as well as 'Rewire your mind: tapping the potential within clinical practice' by Jacqueline Baker and Sonia Matiuk.

2. To form new and strengthen existing professional relationships within neuroscience nursing.

It was such a lovely feeling to arrive at the conference and be greeted with familiar faces (especially lovely as I was travelling on my own!). It was fantastic to see friends from ANNA, the last time being at the Tasmanian conference last year. I met some wonderful and inspiring nurses both from around Australia and overseas who I will be remain contact with and hopefully see at future conferences.

3. To bring my ideas and knowledge to an international arena and inspire change in practice.

My poster presentation on painful stimulation used by nurses in the GCS highlighted some issues that are relevant to every neuroscience nurse conducting neurological assessment. During the poster session I spoke to many nurses whose clinical areas were using techniques not in line with current evidence. I saw many nurses interested, inspired and excited to take back this information back to their own areas.

It is important that information, new knowledge and insights from the conference is shared amongst my colleagues. Since being back, I have spoken extensively with many of the nurses and shared my lessons and experiences. Formally, I will be giving a number of inservices on the ward summarising the conference. I have also been asked to speak at the ANNA and RPA 'Neuroscience Symposium' coming up in November which will involve the local speakers that presented at the WFNN congress- looking forward to that!

Overall, I had a fantastic 4 days at the WFNN 2013 Congress and can't thank ANNA enough for the opportunity in assisting me to attend. I look forward to the next gathering and seeing all of the familiar faces again.



Barbara Lester Scholarship post Congress Report

The WFNN Congress 2013 was themed around Integration, Knowledge, Skill, Clinical Practice and Education of neuroscience nursing. The Barbara Lester Scholarship enabled me to achieve a number of objectives through attending and presenting at the congress. My poster 'Aneurysmal Subarachnoid Haemorrhages a Retrospective Cohort Study' was well received and the feedback that I received was really positive and I look forward to further presenting my work at both a national and international level. My poster outlined my PhD research project that aims to describe the incidence, demographic characteristics, risk factors and presentation of aneurysmal subarachnoid haemorrhages in Tasmania, with the ultimate goal of applying these findings to developing guidelines to assist with the initial assessment of individuals and improving time to treatment. The opportunity to discuss my research with other international colleagues was invaluable and will help in guiding my work over the next few years.

Attendance at the congress has enabled me to contribute to ANNA and the wider neuroscience community. It was a wonderful experience to be able to represent ANNA and network with likeminded academic, professional and clinical colleagues. I look forward to sharing some of the new knowledge and insights that I have gained at the 2014 scientific meeting and through my continued publication in the Australasian Journal of Neuroscience. I was also able to attend the Pre-Congress Workshop run by Linda Littlejohns. Linda's presentation 'Tying Brain Anatomy and to Patient Assessment' was really insightful and a good reminder of the vital knowledge that students needs when embarking on a neuroscience career.

Barbara Lester's commitment to neuroscience nursing has demonstrated the value of building global networks in neuroscience nursing. Attendance at the Congress has enabled me to participate in building global networks and opportunities for collaborative partnerships that can be utilised to generate research and educational opportunities in Australia. From this outcome the congress has given me the opportunity to experience frontiers of contemporary neuroscience nursing knowledge from a global perspective. We often forget about the context of our workplaces and this is what makes things so special. There were a number of inspirational presentations some who were embarking on what might initially appear to be a simple change in practice only for the audience to realize that within their context they were incredibly difficult project to undertake. It really does remind us not to take our health care systems and equipment funding opportunities for granted. We often forget to think outside the square and to look at some of the simpler solutions.

Sharing current research and identifying strategic research concepts on a global stage is fundamental to the continued growth of neuroscience nursing in Australia. From my contribution at the Congress and from the networking and collaborative opportunities, I am uniquely placed within my role as a tertiary educator to identify, explore and transfer contemporary knowledge and advances in global neuroscience nursing to current and future student nursing practitioners. Discussions were held with the Neuroblend Foundation, sharing resources and opening up neuroscience education is vital to strengthening and improving the level of education that we provide and I look forward to discussing further collaborations with Paul and the NeuroBlend team.

I would like to again thank the committee and the Barbara Lester Scholarship fund for the opportunity to attend the WFNN congress. The congress was fantastic, the quality of posters and presentations was excellent and friendships made will last a life time.



The Louie Blundell Prize

Closing date: 5pm EST last Friday in March 2014.

This prize is awarded for the <u>best neuroscience nursing</u> <u>paper by a student</u> submitted to the Australasian Neuroscience Nurses Association (ANNA) for inclusion in the *Australasian Journal of Neuroscience* by the designated date each year. The monetary value of the prize is \$500 ALID

Candidates must be, or have been, students in a course as deemed appropriate by the ANNA Executive Committee during the preceding academic year and if they have completed their course must have graduated no more than six (6) months prior to submission of the paper. Types of papers that will be considered include case studies, reviews of literature, and research reports.

Each candidate for the prize must be the sole author of the paper and may only submit one paper for the Best Neuroscience Nursing Student Paper Prize.

Candidates should <u>not</u> have had a previous publication as a solo author.

ANNA reserves the right not to award the prize if no paper is of a satisfactory standard. The decision of the ANNA Executives is final. All candidates will be notified of the outcome in August.

A minimum of 3 judges will be appointed by ANNA to review the papers and report to the Executive Committee.

The award will be made based on the standard of scholarship of the paper. The qualities that the judges will be looking for are:

- Originality of the work
- The relevance and importance of the topic to current neuroscience nursing practice
- Evidence of reflection consistent with the level of the student
- Comprehensiveness, clarity and conciseness
- Conformity to the Guidelines for Authors, as specified in the Australasian Journal of Neuroscience

The author of the winning paper is required to submit the paper for publication in the *Australasian Journal of Neuroscience* and encouraged to present the paper at the

Annual Scientific Meeting. At the discretion of the Journal Editor, all applicants, whether selected for a prize or not, may still be encouraged to submit their paper for publication, oral or poster presentation at the Annual Scientific Meeting. The judging process will form part of the peer review process for publication and as such recommendations may be made to the author prior to publication.

Registration, accommodation and travel arrangements are at the individuals' expense. Application for scholarships from ANNA or other organisations is encouraged.

Louie Blundell, was born in England, and although she wanted to be a nurse she had to wait until after World War 11 to start her training as a mature student in her late twenties. Later she and her family moved to Western Australia in 1959. She worked for a General Practice surgery in Perth until a move to the Eastern Goldfields in 1963. Subsequently, she worked at Southern Cross Hospital and then Merriden Hospital. During this time she undertook post basic education to maintain her currency of knowledge and practice, especially in coronary care.

Louie was also active in the community. She joined the Country Women's Association and over the years held branch, division and state executive positions until shortly before her death in 2007. She was especially involved in supporting the welfare of students at secondary school, serving on a high school hostel board for some time. She felt strongly that education was important for women and was a strong supporter and advocate of the move of nursing education to the tertiary sector, of post graduate study in nursing and the development of nursing scholarship and research, strongly defending this view to others over the years.

- Nurses must have current registration in their state/territory/country.
- The conference presentation or workshop/breakout session must have relevance to the neuroscience specialty.






Report


I recently had the privilege to attend the 11th Quadrennial Congress of the World Federation of Neuroscience Nurses in Gifu, Japan in September with the kind financial support of a John Sheard Travel award from the ANNA NSW Chapter. This award is open yearly, and I encourage members to apply for this generous award.

I travelled with fellow neuroscience nursing colleagues Dr Jacqueline Baker and Sonia Matiuk from UTS. I was able to spend some time travelling in Osaka and Kyoto before and after the congress to explore this beautiful country. The congress provided the ability to network with old and new friends from Australia and across the globe. Due to the regional proximity of the conference, there were many Sydney hospitals represented with clinicians from Liverpool, Nepean, Westmead, Royal North Shore, Royal Prince Alfred, and St Vincent's to my knowledge. There were plenty of opportunities to engage in some of the many cultural experiences on offer from traditional green tea and cakes to origami paper kangaroo making! The Japanese hosts were very welcoming and accommodating. For me a highlight session was from the Japanese experts who have managed to provide actions to thoughts to help paralysed patients, particularly with locked-in syndrome. They have titled this technology - Brain-machine interface. This shows particular promise to enhance the quality of life with such conditions. I was intrigued to the cost of such innovative cutting edge technology, only to be informed it would be somewhere in the region of 1 million dollars.

The poster session provided a great opportunity to mingle and discuss individual projects with the researchers and clinicians. I presented a paper on Massive Open Online Courses (MOOCs) and their implications for neuroscience nursing, and the need for practice readiness and clinical skill development at postgraduate level. Whilst MOOCSs are an innovative method of course delivery, there still remains a need for face to face interaction in specialty nursing education.

Another highlight of my time at WFNN was the important theme of caring and rehabilitation throughout the conference. I enjoyed learning about new methods of inter-professional and blended education.







The 11th WFNN Congress was a great success with 485 delegates as well as 203 students, giving a total of close to 700 attendees travelling from around the globe, including countries such as Australia, Austria, Belgium, Brazil, Cameroon, Canada, China, Croatia, Denmark, Finland, Ghana, Hong Kong, India, Iran, Japan, Korea, Mongolia, New Zealand, Norway, Sweden, Switzerland, The Netherlands, United Kingdom, United States.

The Japanese were very hospitable and included sessions for Kimono, Tea Ceremony, Calligraphy and Origami. Delegates were treated to a "dinner cruise" experiencing the ancient art of Ukai (cormorant) fishing. Luckily this occurred before typhoon Man-yi advanced toward central Japan with heavy rain, flooding and strong wind warnings. It was good to see that our overseas mobile phones could pick up (albeit Japanese character writing) the emergency alert signals!

The Scientific Program was vast, covering a wide range of neuroscience topics. There were several other lectures as well including the -

- Pre Congress Workshop by Linda Littlejohns—"Tying Brain Anatomy to patient assessment",
- 3 x Special Lectures—"Nursing patients with long term disturbance of consciousness: current status and future prospects in Japan"; "Brain-Machine interface"; "Origin and essence of caring in healthcare".
- 3 x Luncheon Seminars—"Lessons learned in WFNN"; "NeuroBlend"; "Concussion in school sport".
- 45 x oral concurrent sessions
- 36 x posters

There was a change in the WFNN Executive with Virginia Prendergast stepping down after 20 years in the leadership position. The new WFNN Executive Committee is -
